

Several Local Tax Issues for Voters this November

Medina County voters will determine the outcome of 17 tax issues at the November 7 elections this year, seven of which are requests for additional money.

County residents have until Tuesday, October 10 to register to vote in the November election. Early absentee voting for the election begins Wednesday, October 11 and runs through November 6. In-person absentee voting takes place at the Medina County Board of Elections, 3800 Stonegate Drive, Suite C, Medina.
